Absolute confidentiality of the information exchanged between the Partners concerning the subject matter of this Agreement shall be strictly maintained.

8. Termination:

Either Partner may, without any termination obligations and liability, terminate this Agreement for any reason by providing notice in writing of at least 60 days to the other Partner.

9. No Legal Obligations:

The Partners agree that provisions contained in this Agreement does not create any legal obligations between the Partners, save for the Confidentiality provisions and Termination provisions in this Agreement.

10. Assignment:

This Agreement cannot be assigned to any third party, without the prior written consent of the other Party.

11. Financial Liabilities:

- This Agreement is being signed purely without any financial liabilities. **No fee will be charged from the students for the personality development lectures described in Point 1. under "Details of Understanding" section.**
- Any monetary contribution towards the YES!+ for students and Capacity Building Programs for teachers and staff shall be borne by the interested students/faculty/staff on a voluntary basis. The amount shall be paid by the students on a voluntary basis to TAOL before the commencement of the program.

11. Limitation of Liability:

Except for claims that may arise pursuant to confidentiality and termination clauses, in no event shall either Party be liable to the other for any damages including, without limitation, direct,



speculative, indirect, incidental, special or consequential damages in connection with this Agreement.

12. Governing Law and Jurisdiction:

This Agreement shall be governed by and construed in accordance with the laws of India and subject to the jurisdiction of the state of Karnataka.





- f. Performing Academic activities like Lions Quest workshops, Career guidance, Youth fare and other youth related activities for personality development of students.




DURATION AND RECINDENCE OF MOU

The Memorandum of Understanding (MOU) establishes the following:

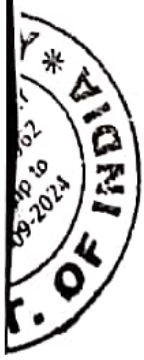
1. OBJECTIVE OF THE AGREEMENT

- 2. Exchange of books, scientific publications, study programs, academic projects, course information, seminars, conferences and any other data and information of common interest
- 3. Develop joint research projects and joint publications
- 4. All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations of the appropriate institute entity

3. IMPLEMENTATION OF THE MEMORANDUM OF UNDERSTANDING

The objectives of the MOU will be implemented and regulated in the following manner:

i. Student Exchange

- a. Students and research scholars may visit the corresponding departments of these institutes after finalizing a mutually acceptable schedule
